**PERIODS FOR WHICH THE TARIFFS ARE SET**

**FIXED SERVICE AVAILABILITY CHARGES - BILLING PERIOD:**

Fixed service availability charges apply for water supply and sewerage services, as detailed in this Notice. These are set for an annual period (1 July 2022 to 30 June 2023) and are billed and payable on a three-monthly basis as follows:

- 1 July 2022 to 30 September 2022
- 1 October 2022 to 31 December 2022
- 1 January 2023 to 31 March 2023
- 1 April 2023 to 30 June 2023

**WATER CONSUMPTION CHARGES - BILLING PERIOD**

The charges for Water Supply are based on the amount used. These apply for the period from, the last meter reading prior to 1 July 2022 until the next meter reading before 1 July 2023.

**CALCULATION AND PAYMENT**

For Residential and Non Residential, these are calculated & payable:  
 • based on meter readings conducted over the year;  
 • with each quarterly account for the periods ending 30 September; 31 December; 31 March and 30 June.

**THE METHOD FOR CALCULATING TARIFFS**

**FIXED SERVICE AVAILABILITY CHARGES**

Tariffs in relation to the Fixed Service Availability Charges are set out in the table to the right and relate to each of the three monthly charge periods.

**WATER**

Fixed Service Availability Charge is based on meter size and applies to ALL serviced properties in Lower Murray Urban & Rural Water Corporation's Urban Water Districts.

Fire Services are \$196.00 per annum (or \$49.00 per billing period) per service.

**WASTEWATER**

A Base Charge of \$508.64 per annum (\$127.16 per billing period) for all sewered properties. The Base Charge will form the respective basis of the calculation of the Fixed Service Availability Charge. Specific formulas relative to property classification and the potential load are used. Details are available from LMW.

Minor Trade Waste Charge is \$70.76 per unit per annum, where applicable.

**THE DATE BY WHICH TARIFFS MUST BE PAID**

**RURAL**

All Rural tariffs and charges must be paid by the date specified in the invoice provided and failing any date being specified in that invoice, 28 days from the date of issue of the invoice.

The date on all invoices represents the final date that the payment will be accepted interest free. Invoices will be mailed late July, October, January and April. Invoices can be delivered electronically via BPAY View.

Interest shall be payable in respect to all amounts payable under a tariff or charge if the amount is not paid by the due date.

**URBAN**

All charges under the Urban tariffs, either based on a three-monthly period or on a meter reading, must be paid by the date specified on the invoice provided and failing any date being specified in that invoice 28 days from the date of issue of the invoice. Invoices can be delivered electronically via BPAY View.

**CONCESSIONS**

Recipients of eligible Centrelink or DVA concession cards may be entitled to a concession on:

- Irrigation Districts, Domestic and Stock Supply Charges
- Urban/Rural Millewa Districts where applicable
