Guide to the Notice in Writing of Intention to Terminate Delivery Share

The purpose of this notice is to inform the Water Corporation of your intention to terminate or surrender delivery and/or drainage share.

It is a requirement of the Water Charge (Termination Fees) Rules 2009, approved by the Commonwealth Minister for Water, that water agencies hold a notice in writing from the land owner who wishes to terminate/surrender delivery share before it can impose a termination fee.

The calculation of the termination fee is based on the Total Network Access Charge (TNAC) that is payable by the land owner in the financial year in which the notice of surrender/termination was given or specified within the notice.

The calculation of termination fees is unique to each customer and will be formally advised in writing to the applicant(s) on the receipt of a notice in writing of surrender/termination of delivery share.

On the receipt of the formal termination fee advice from Lower Murray Water (should you wish to continue the surrender/termination of delivery share) other regulatory requirements may apply. Lower Murray Water requests customers seek information and advice on the various requirements that they may be subject to in the restructuring of their property's water demands.
