

Terms & Conditions

Price Submission 2028 – 2033 Water MythBusters



1. Eligibility

The promoter is Lower Murray Urban and Rural Water Corporation, trading as Lower Murray Water (LMW).

- 1.1 Entry is open to Lower Murray Water (LMW) customers who hold an active LMW account for a service address within an LMW-serviced postcode.
- 1.2 To be eligible, entrants must react to one of the 'Water MythBusters' question posts on LMW's Facebook page by selecting Like or Love and share that post.
- 1.3 Each eligible 'Water MythBusters' post that an entrant reacts to by selecting Like or Love and shares will count as one entry. An entrant may receive a maximum of six entries during the competition period. Entries that do not meet these requirements may be deemed invalid.

2. Entry Period

- 2.1 The competition opens at 9 am on Monday, 31 August 2026 and closes at 5 pm on Thursday, 17 September 2026.
- 2.2 Entries received outside this period will not be eligible.

3. Prize
